The following constitutes the Jiggs Conservation District Annual Plan of Work for the fiscal year 2018, July 1, 2017 – June 30, 2018.

Mission Statement

To take available technical, financial, and educational resources, whatever their source, and focus or coordinate them so that they meet the needs of the local land user for conservation of soil, water and related resources.

Planning and Service

Provide for involvement of other agencies, organizations and individuals in the annual planning and implementation of district operations and programs.

- A. Identify and prioritize Resource Concerns within the District in order to coordinate with the NRCS in resource planning and program implementation.
- B. Cooperate and support the Humboldt Watershed CWMA.
- C. Continue cooperation with the NRCS on the snow survey program.
- D. Encourage the USFS to support the NRCS soil surveys.
- E. Continue a noxious weed control assistance program.
- F. Continue and increase noxious weed control efforts within the district boundaries.
- G. Continue cooperation with other groups and agencies on a rehabilitation project in the South Fork Watershed.
- H. Manage the district equipment program for benefit of cooperators in implementing conservation practices.
- I. Assist NRCS on outreach programs to ensure that all land users are aware of available assistance.
- J. Continue cooperation with all agencies on water quality problems when identified within the District.
- K. Assist Public Land agencies with fire prevention and fire rehabilitation issues.
- L. Cooperate and coordinate with the Jiggs and Ten Mile Volunteer Fire Departments on fire related issues.
- M. Monitor the biological control project of Leafy Spurge and Canadian Thistle along the Ten Mile Creek, South Fork River and the Ruby Mountains.
- N. Continue to participate as coordinating agency with the BLM, Forest Service, NRCS and other federal agencies.
- O. Cooperate with a Creeks and Communities workshop agencies are planning within the District and bring the concepts into the Plan of Work where ever possible.
- P. Collaborate with the State of Nevada Sagebrush Ecosystem Council on projects for habitat preservation and restoration.

Information and Education Program

- A. Consider participants requesting to be sponsored for attendance to the annual Nevada Youth Range Camp.
- B. If requested, consider assistance to schools within the district on conservation education.

Management and Administration

- A. Hold regular meetings to which all cooperating agencies and public are invited (in accordance with NRS 241.020-3(b)).
- B. Continue to contribute to the Elko County Association of Conservation Districts.
- C. Submit all reports and financial statements to the Nevada Division of CD's by their respective due dates.
