These revisions will update NAC to be in accordance with Nevada Revised Statute. In 2023, the Legislature passed Assembly Bill 164, which updated the tasks of the Advisory Board on Outdoor Recreation to serve as the Technical Advisory Committee for the Nevada Outdoor Education and Recreation grant program. Additional revisions include updating the limit on grants that can be reviewed by the Division and eligible projects.
