Completed FY2020 Annual Work Plan Items

Management and Administration:

- Meeting notices were posted in accordance with the Nevada State Open Meeting Law.
- Minutes and agendas for all district meetings were submitted to the Nevada Division of Conservation Districts and State NRCS Office and provided to all entities that participated with the district.
- Dues paid to NVACD.
- Supervisor elections were held per state and federal guidelines.
- COVID-19 state guidelines were followed by WPCCD.

Education and Outreach:

- Started a scholarship fund to help individuals interested in agriculture or other natural resource related fields. The CD's first scholarship recipient is interested in pursuing a degree in environmental engineering. This field will allow her to continue to enjoy the outdoors while figuring out new ways to protect and conserve it for future generations.

- CD chair participated with the White Pine Coordinated Resource Management Steering Committee.

Soil Conservation:

 White Pine CD supported efforts by the local NRCS office to improve initiation and completion of EQIP projects on public and private lands, fostering the relationship between the agencies. Work completed by NRCS included Brush management of 246.3 acres, fence 6,611 ft, irrigation pipeline 18,850 ft. New conservation plans were developed on private (3) and public range allotments (9), with nine new contracts worth over \$853,308.00.

Weeds:

- The conservation district continues to partner with Eastern Nevada Landscape Coalition to have Tri County Weed inventory and control weeds within the conservation district.

Wildlife:

GBI PJ Removal on BLM

This project involves pinyon and juniper removal in partnership with Great Bain Institute Conservation Corps Program (GBI). GBI has obtained a grant for \$50,000 from National Fish and Wildlife Foundation (NFWF). The requirements of this funding are, it needs to be spent on public land and it needs to have a 1:1 match of non-federal dollars. White Pine Conservation District (CD) is in a unique position to partner with GBI to continue ongoing work that NDOW is currently partnering with BLM in North Cave Valley. The CD in coordination with NDOW and BLM has identified 473 acres of PJ just west of Cave Valley Ranch on BLM land that are approved for removal. GBI is in the process of completing the project.

Cave Valley Ranch Mastication and Seeding

Additional Heritage funds in the amount of \$50,000 have been awarded to finish the 2018 project by masticating the remaining piles and purchasing additional seed. This second masticator rental will be utilized to masticate remaining piles and allow for drill seeding. The landowner will provide a large amount of match to finish this project by operating the masticator and purchasing fuel. He will also drill seed once mastication is complete.

Annual Work Plan

FY 2022

The annual work plan for the White Pine County Conservation District (WPCCD) was developed and adopted by the WPCCD board of Supervisors on <u>04/29/2021</u>.

The plan contains the following key components to be addressed by the WPCCD in FY 2022.

- Management and Administration
- Education and Outreach
- Conservation Efforts (soil, water, wildlife habitat)
- Noxious and Invasive Weeds

MANAGEMENT AND ADMINISTRATION:

- Pay yearly dues to NVACD and NACD as funding allows.
- Post meeting notices in accordance with Nevada's open meeting law.
- Submit minutes and agendas within 30 days to the Nevada Division of Conservation Districts and State NRCS office.
- Submit financial statements, budgets and reports as required by state directives to ensure eligibility for grant funding.
- Maintain a list of projects that can be implemented as funding opportunities become available. Work with other state and federal agencies to identify high priority areas and projects.

EDUCATION AND OUTREACH:

- Develop a list of outreach opportunities to better inform the public of what the conservation district is doing on their behalf.
- Develop specific outreach to landowners about what the CD has to offer, especially when it comes to projects.
- Work with Cooperative Extension to visit with junior high and high school students that are interested in agricultural and natural resource fields and support local attendance at the Nevada Youth Range Camp.
- Provide judging support at the White Pine County Fair for the crops and gardens division.
- Set up a booth at the White Pine County Fair to update the public on CD activities.
- Work with local high school and Great Basin College relative to scholarships for deserving students in agriculture/natural resource related majors.
- Provide leadership for conservation week.
- Organize the annual dinner meeting and silent auction.
- Attend annual Nevada Conservation Meeting.
- Work with Coordinated Resource Management planning, actively engaging in the CRM process.
- Utilize grant programs to help facilitate, promote and finance Conservation District resource programs.

CONSERVATION EFFORTS:

Soil

- Work with county residents to complete a conservation action plan to compliment the Resource Needs Assessment.
- Fire Rehabilitation

Water

- Work with landowners to improve the efficiency of spring and trough systems.

Wildlife Habitat

- Provide oversight for GBI and Heritage projects.
- Provide oversight for Cave Valley and Duck Creek Basin pinion/juniper projects.
- Identify additional wildlife and sage grouse enhancement projects that are ready to be implemented when grant opportunities or other funding becomes available.

NOXIOUS AND INVASIVE WEEDS:

- Support local Coordinated Weed Management Areas (CWMAs).
- Identify hotspot areas that should be a priority for treatment
- Pursue grant opportunities as they become available.
- Help keep County and City officials appraised of noxious weed and pest infestations and control efforts in cooperation with the County Extension Office, Tri-County Weed Control and the Nevada Weed Management Association.
