Annual Work Plan -Fiscal Year 2021/2022

This district works to achieve a stable, healthy river system that provides for abundant agricultural production, wildlife habitat, stable riverbanks, and high-water quality conditions. This district works to achieve cooperative relations where the private landowners, county, state, and federal agencies maintain their lands and work cooperatively, and openly, to solve natural resource problems. Furthermore, this district assists local agricultural producers with protection of their surface water conveyance systems.

Financial Summary

The Carson Valley Conservation District seeks out many projects-based grants from federal, state, and county providers. From 2021-2022 the operative budget for the CVCD is \$1,397,036.35

Streambank Stabilization, Channel Clearing, Snagging, and Maintenance

Along the Carson River, there are multiple areas that have been identified as requiring stream bank stabilization, restoration, and maintenance. Within existing designated restoration sites, the district will perform channel clearing, snagging, and maintenance to help protect the past and future engineered structures. Willow growth, as well as sand and gravel deposits have become heavy on the inside banks and are encroaching into the channel. The net effect has been seen in the reduction of channel capacity by an estimated 25% at high flows in some areas. Loss of channel capacity, along with stream bank instability, may threaten nearby structures. The effect of in-stream vegetation has pushed flood flows into the outside bank causing significant stress and erosion. Stream bank failure could occur at high flows, and threaten nearby structures, erode old growth Cottonwoods, and have a negative impact to water quality. These projects remove in-stream vegetation and this vegetation may be used for future rehabilitation projects.



The district has identified multiple locations that have been restored in the past that require additional maintenance to ensure that they are functioning correctly. The district has solicited several bids for a contractor/operator, an excavator with operator and a chain saw with operator to complete work within these project areas.

Bioengineering/Erosion Control

The district has continued its ongoing bioengineering work to fix the eroding river, stream, and slough banks. This job opportunity has allowed the district to keep a trained crew busy for almost 11 months out of the year actively working on noxious weed control and bioengineering projects. Bioengineering works incredibly well to stop sediment from being dumped into the river which would further degrade water quality. Bioengineering also provides habitat for wildlife in the water and along the banks. The crew works to plant trees to take root and provide a matrix of roots for the soil on the banks. This has helped hold the stream bank in place, preventing further degradation. Bioengineering proves to crowd out noxious weeds which are usually the first vegetation to show up to any disturbed earth site. Some noxious weeds like Perennial Pepperweed have an expansive non-fibrous root system that causes the bank to crumble and drop sediment into the waterway. Our bioengineering competes with most noxious weeds, but the projects must be monitored and maintained. Funds for monitoring and maintenance run thin, but the project sites require the work to remain a success. This district hopes to complete six streambank stabilization projects this year.

Floodplain Rehab, Reseeding and Stormwater Mitigation

The CVCD is now nearing completion and restoration of the multiple properties within the floodplain. This project site encompasses over 2,500 acres within the Carson River corridor in Carson Valley, Douglas County, Nevada. These projects have presented a crucial opportunity for restorations and encourage beneficial use of severely degraded lands including the River Corridor, floodplains, and riparian zones. Overall restoration efforts in the future will occur within the 100-year floodplain. Due to the extent of the project, this work has been in progress in phases over the last two years. The project started in 2018 and is continuing to improve the Carson River floodplain with each passing season. The Nevada Department of Agriculture has been our major partner in helping keep our floodplain treated and reseeded.

The riparian area near the river channel has been severely impacted and the floodplain is currently infested with Perennial Pepperweed, Hoary Cress, Yellow Starthistle, Tamarisk, Knapweeds and Thistles. The stream banks within the treated areas are protected using a series of engineering treatments to deflect the highest velocity possible away from the banks. Bioengineering structures assist in providing physical stability and ecological improvements. This project has been utilized in floodplain areas as well as private agricultural areas that have been decimated by drought and past flooding events. The district actively works with project stakeholders in removing decadent materials, treating invasive weeds, and re-seeding with native or desirable vegetation to improve habitat, vegetation density, and water quality. The district is



working directly with the Douglas County Stormwater program to help mitigate damage to the Carson River and its tributaries by actively minimizing erosion and water quality issues.

Running NDOT Drainage and Stormwater Contract

The district has entered a trial program with NDOT to help them with private property issues for drainage repairs and maintenance. This program is run by district staff who manages the projects, crews, payroll, materials, equipment, permits, and fees. The district signed a five-year interlocal agreement with the Nevada Department of Transportation which will be valid until 2024. This program has helped the State of Nevada mitigate damage to adjacent landowners because of stormwater erosion. To date, the program has expended over 8 million dollars in funding to help improve impacts from stormwater runoff.

Cooperative Weed Management

The CVCD continues to develop a cooperative partnership with Douglas County for weed management. The district has received funding from the Nevada Department of Agriculture, Carson Water Sub-conservancy District, and Douglas County in the past to continue the district's weed control program. The weed control program involves the identification, mapping, and prioritization of specific noxious weeds to control and implement a treatment strategy. To carry this out, the district relies on assistance from local private landowners for help with identification, location, and herbicide application in controlling noxious weeds within the district boundary on county, state, federal and private lands. The district has applied for Nevada Department of Agriculture funding to treat large weed infested agricultural lands along the Carson River. Another component of the request allows the district the ability to replant native and desirable vegetation for both domestic and wildlife habitat. The district has submitted funding requests to the Nevada Department of Agriculture, Carson Water Sub-conservancy District and Douglas County.

Along with controlling invasive weeds, the district utilizes a GPS unit to map the known locations of noxious weeds in our district boundary so the information can be tracked annually and submitted to the Nevada Department of Agriculture for incorporation into the Nevada State Weed Map.

Conservation Education

For the last 18 years, the CVCD and River Wranglers have helped organize and implement annual Carson River Workdays in Douglas County. These events provide the opportunity for elementary school children to visit the Carson River and learn about the watershed in which they live. The CVCD continues to support local youth in attending the Nevada Range Camp held annually during the month of June. The district sponsored three local youth to attend the annual range camp. The district requires the youth to come back to the board and present what they learned at Range Camp. Since the Covid outbreak we have not had any in person events however staff has created a webpage highlighting our work and project partners



Successful Invasive Weed Treatment and Mapping

The CVCD has worked with project stakeholders to develop a weed treatment strategy through the funding of the Douglas County Weed Program. This weed control effort has been expanded to treat and map thousands of acres over the past years and improves the education outreach effort regarding the impacts of invasive weeds on natural resources. This allows the district the ability to inventory and verify if treatments are working as intended. The district is partnering with the Nevada Department of Agriculture to establish the EDD MAPS program which inputs our district mapping data into a large database for comparison purposes. In addition to mapping the district received a grant in 2018 from the Nevada Department of Agriculture allowing the purchase a 10' no-till drill allowing us to seed into treatments areas. This overseeding process puts desirable, or native species, back in areas disturbed by noxious weeds. This successful program has helped the CVCD treat thousands of acres of invasive weeds including the tributaries which enter the Carson River Corridor, as well as vital agricultural lands. The district continues to do the noxious weed work for the county and agricultural producers. This program has had great success and was to be copied by the state as the model weed control district set up. The district model prioritizes projects based on parcel size, weed free crops, targeted species, access, risk of spread and where a particular weed might end up on our "Hit List". Our block grant is used by all the CWMA's in our region of the state as match for the Noxious Weed. Our proprietary system for noxious weed control is find them, identify them, photograph them, map them, treat them, and check back and retreat if necessary, retreat and seed if the funding is available. The district will be applying for grant funding to acquire a drone which will be used for several projects. Some of these projects include weed mapping/inventory, aerial weed herbicide treatments, floodplain mapping and monitoring, and river restoration monitoring.

Sage Ground Liaison for NRCS

The CVCD has entered into a formal agreement with the NRCS Minden Office to aid on acquiring conservation easements or doing projects that will enhance water quality or wildlife habitat. This agreement puts a particular emphasis on the Bi-State population of the Greater Sage Grouse. The agreement is scheduled to run through September 2021 and is budgeted for \$20,000. This agreement has been extended to run through September 2022.
