Operation & Events

The board members met every other month this year to discuss programs and conservation concerns. Meetings were held in the conference room at the Agricultural Service Center, 111 Sheckler Road in Fallon, Nevada.

The District complied with the requirements of the Conservation Commission by submitting agendas, minutes, budgets and annual reports.

Stillwater Conservation District has dues paying cooperators involved in District programs.

District Programs

The district has continued to manage a successful Equipment Rental Program. Goforth Equipment Manager, who takes care of the maintenance and repairs. The District Rental Equipment includes a No-Till Drill, Dump Truck, Backhoe, and Grader. The No-Till Drill is a conservation tool that allows farmers to replant without working the ground, which saves labor, fuel, and water.

The district used \$2,500.00 of the State's Funding for the Noxious Weed Program. Seventeen landowners received two and a half gallons of 2,4-D Broadleaf Herbicide and two and a half gallons of AquaMaster herbicide. Noxious weeds that were treated included: knapweed, puncture vine and perennial pepper weed.

Education

The district goal of educating students about the importance of conserving natural resources in Nevada. This year Stillwater Conservation District was able to sponsor one youth to attend the Nevada Youth Range Camp.
